**What Personally Identifiable Information is Collected**

Center Members and other website visitors that register for trainings through [www.preventionservices.org](http://www.preventionservices.org) voluntarily provide us with contact information (such as name

and e-mail address). We use this information internally for providing personalized service and for monitoring website traffic.

### **Credit Card Account Information**
